



A guide to your electricity bill with solar usage charges

Following is an explanation of how the Account Breakdown section of your electricity bill will look now that you have solar on your roof and have entered into a Solar Power Purchase Agreement (Solar PPA) with us.

Electricity Charges

This section sets out your existing electricity charges by tariff.

Queensland Solar Scheme

This section lists the current reading of your solar meter. This section also shows the credit you received for the solar electricity you did not use which was exported back to the electricity grid. Please note, the credit listed here is reversed in the 'Other Charges & Credits' section. This is because for this solar trial, your Solar Purchase Power Agreement (Solar PPA) means you can save money by paying less than the price of grid electricity for the solar electricity you use, rather than receiving a credit for the solar electricity that is exported back to the grid.

Other Charges & Credits

You'll find your Solar PPA usage charges here. There may be other information in this section like your Clean Energy subscription, Royal Flying Doctor Service donation, Meter Services Charges and if you are eligible, credits from the Queensland Government Electricity Rebate.

In the example below, the customer has a Royal Flying Doctor Service Donation of \$1.00 per bill.

The following line items are for the solar usage:

- **Solar PPA** - the days covered by this bill
- **Total Generated** - the total amount of solar electricity generated by the panels in kilowatt hours (kWh)
- **Total Exported** - the total amount of solar electricity exported back to the grid in kWh
- **Solar Usage Charge** - the total amount charged for the solar electricity used in your home
- **Solar Export Charge** - the equivalent reversal rate of the credit that was applied in the Queensland Solar Scheme section for solar electricity that was exported back to the grid.
